## Eastridge Elementary Title I Parent Engagement Plan Revised 5/22/18 Amarillo Independent School District

- 6. Eastridge Elementary will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

  - Translators are available
- 7. Eastridge Elementary will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:
  - Reviewing and understanding the state's academic content standards.
  - Reviewing and understanding the state's student academic achievement standards.
  - Reviewing and understanding the state and local academic assessments including alternative assessments.
  - The requirements of Title I, Part A.
  - How to monitor their child's academic progress.
  - How to work with educators.
  - Skyward Family Access
- 8. Eastridge Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:
  - Library Night/Literacy Night.
  - Tenants' Rights & Community Education
  - Discovery Center Family Science Night
  - Skyward Parent Training
  - Parent engagement programs
- 9. Eastridge Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools.
